Risk Briefing – full text

1. Risk Briefing

I acknowledge that water activities such as SUP, kayaking, canoeing, rafting, packrafting, rubber-boat trips, paddling tours and comparable leisure activities are associated with typical risks despite careful organisation, tested equipment, safety briefing and accompaniment by guides. These risks include in particular:

- capsizing or falling into the water;
 - currents, eddies, shallows, slippery stones and changing water levels;
 - collisions with boats, bridge piers, stones, wood, shore areas or other obstacles;
 - hypothermia, exhaustion, sunstroke, heat, weather changes or thunderstorms;
 - cuts, bruises, sprains, blunt or crushing injuries or other injuries;
 - loss of or damage to personal items;
 - dangers from independent behaviour or non-compliance with instructions;
 - risks from other water users, animals, natural events or unforeseeable circumstances.
- I understand that these risks cannot be completely eliminated.

2. Personal Requirements

I confirm (for registered minors as legal guardian):

- sufficient swimming ability, at least 15 minutes free;
- physical and mental fitness to participate;
- no influence of alcohol, drugs or significantly impairing medication;
- TraunXperience has been informed about safety-relevant health conditions;
- in case of discomfort, anxiety, pain, exhaustion or danger the guide will be informed immediately;
- necessary medication is carried waterproof and within reach.

3. Safety Briefing & Conduct

Before every tour a safety briefing is given at the meeting point. I confirm:

- participation in the safety briefing with the opportunity to ask questions;
- immediate compliance with the guide's instructions;
- wearing the life jacket on the water for the entire tour;
- wearing a helmet when required or instructed;
- use of released entry/exit points only, no navigating closed areas;
- no entering private property without consent;
- respect for nature, animals, shore areas, gravel banks, reed and protected zones, no litter;
- no risky jumps, boat changes, dares or independent manoeuvres;
- no leaving the group on my own initiative.

4. Equipment

I use the equipment provided carefully, properly and only as intended, and report damage, loss or malfunctions immediately. Final handover and function check happen at the meeting point.

5. Liability

I am aware that TraunXperience is liable for personal injury in accordance with statutory provisions. For other damage, TraunXperience is liable in accordance with statutory provisions and the applicable General Terms and Conditions. TraunXperience is not liable for damage caused exclusively by my unauthorised, contract-breaching or safety-violating conduct, in particular through:

- non-compliance with safety instructions;
 - false statements regarding swimming ability, health or fitness;
 - participation under the influence of alcohol, drugs or significantly impairing medication;
 - leaving the group on my own initiative or use outside the agreed area;
 - navigating closed areas;
 - wilful or improper use of equipment;
 - disregard of nature, water, navigation or safety rules.
- Mandatory legal rights remain unaffected.

6. Liability for Equipment and Damage

I am liable for damage to equipment or other damage to the extent I have culpably caused it – in particular through improper use, disregard of safety instructions, prohibited transfer to third parties, wilful damage, loss, use outside the agreed area, and culpably caused recovery, retrieval or cleaning. Normal wear and tear and non-recognisable material defects are not at my expense.

7. Personal Items

I carry personal items such as smartphone, camera, watch, jewellery, glasses, clothing, wallet, keys and other valuables at my own risk, unless these are expressly accepted by TraunXperience for safekeeping.

8. Declaration for Minors & Groups

For minor participants I confirm as legal guardian that the minor meets the participation requirements, can swim sufficiently, has been informed about safety-relevant health conditions and the safety rules, and must follow the guide's instructions. For school groups, associations or other groups, the general duty of supervision of the respective teachers, accompanying persons or group leaders remains in place; TraunXperience assumes the technical leadership on the water.

9. Acknowledgement of T&C & Safety Rules

I have taken note of and understood the Terms & Conditions (traunxperience.at/en/terms-and-conditions), the risk briefing and the safety rules, had the opportunity to ask questions, and will immediately notify TraunXperience of safety-relevant changes to my health.
